


MAKING A FEDERAL ESTIMATED TAX PAYMENT ON THE INTERNAL REVENUE SERVICE (IRS) WEBSITE

1) Navigate in your browser to [IRS.gov](https://www.irs.gov).

2) If you have an IRS account, click “[Sign in to Your Account](#)”:

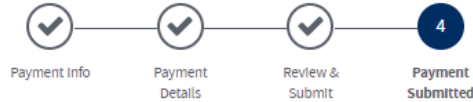
